Fluoride Plebiscite in Calgary Likely to Pass by Comfortable Margin

(CALGARY) After almost a decade without a fluoridated water supply, Calgarians appear ready to re-introduce the cavity fighting agent in this October's plebiscite on the issue according to a recent ThinkHQ Public Affairs survey. The plebiscite measure is likely to pass by a comfortable margin later this month, with almost seven-in-ten (68%) Calgary voters saying they plan to vote in favour of the measure, compared to only 21% saying they will vote "No" and 11% who are still undecided. On a decided vote basis, the results are 76% in favour of re-introducing fluoride to the water vs. 24% opposed.

- Substantial majorities support the measure across demographic categories, though it is somewhat lower among more conservative voters and those who believe the City is on the "Wrong Track" today
- The measure receives slightly higher support among those with kids at home

Commentary



ThinkHQ Public Affairs Inc. President Marc Henry notes the following on these survey results:

"Putting aside the public health debate, fluoridation is the 'Bad Penny' of Calgary municipal politics – this issue just seems to constantly reappear. We've held six plebiscites on the matter since the 1950s, and a decade after Council chose to remove fluoride, its back again.

It's a popular measure with Calgary voters. The plebiscite should pass by a very healthy margin, with support 3:1 over opposition. If it does pass by that wide a margin, perhaps Calgary voters can have some solace in knowing they may not have to deal with the issue again for a decade or two."

Research Methodology



Approach

- Online survey of Adult Calgarians
- Region: Calgary proper
- Field dates: Sept. 13 16, 2021
- **Sample size**: 2021 n=1,109
- Panel source: Angus Reid Forum
- Weighted to reflect gender, age and region of Calgary population according to Stats Canada
- A random stratified sample of panelists was invited to complete the survey from the Angus Reid Forum. The margin of error for a comparable probability-based random sample of this size is +/- 2.9 percentage points, 19 times out of 20
- Accuracy of sub-samples of the data decline based on sample sizes


